Women in educational leadership are quite aware of the importance of having the proper credentialing as evidenced by the preponderance of women now enrolled in and receiving education leadership degrees. However, there are also a number of categories which women in educational leadership positions are passionate about. These include the following: 1) preparedness; 2) hard work; 3) perseverance; 4) good people skills; 5) strong support systems; 6) personal integrity; 7) respect from peers; and 8) a strong belief in yourself. Furthermore, women in educational leadership positions always consider the impact their decisions may have on personal goals, family, and life itself. In September 1985, she was promoted to Area Director in the South Central Area and became South Central Area Superintendent in 1987. From 1988 to 1996, Ms. Cortes served as Region IV Superintendent. In 1996, she was promoted to the position of Deputy Superintendent of School Operations, becoming the first Hispanic female in Miami-Dade County Public Schools to have been appointed Deputy Superintendent. In 1997, she started her tenure as Deputy Superintendent for Management and Accountability and from 2002 to 2005, Ms. Cortes served as Region Superintendent in various regions.

During her professional career, Ms. Cortes has served as Vice President and Recording Secretary of the Dade County Schools Administrators Association. She was a founding member of the Gender Equity Network and a Trustee of the Greater Miami Chamber of Commerce. She also served in the Executive Committee of the Women’s Chamber of Commerce of Miami-Dade County. In 1995, she was awarded the Dade County Schools Administrator of the Year and in 1999, Ms. Cortes received the Cervantes Outstanding Educator Award from Nova Southeastern University. Ms. Cortes was the Vice-President of the Miami-Dade County Retired Educators Association and currently she is serving as President of the Association.

Ms. Cortes received her Bachelor of Arts Degree from the University of Miami, Coral Gables, Florida, with a major in Political and Educational Sciences. In 1974, she graduated from Florida International University (FIU), Miami, Florida, with a Masters of Science Degree in School Administration and Supervision, the first graduating class at FIU.

WHEREAS, in 1996, she was promoted to the position of Deputy Superintendent of School Operations becoming the first Hispanic female in Miami-Dade County Public Schools to have been appointed Deputy Superintendent.
