The Foundation for Music Education awarded the Glades Middle School Concert Jazz Band the Mark of Excellence National Award in 2010, 2014, 2015, 2016. The Mark of Excellence Award was also given to three Outstanding Jazz Soloists in 2014, 2015, and 11 awards in 2016.

Glades Middle School Concert Jazz Band performed at the 69<sup>th</sup> Annual Midwest International Band and Orchestra Clinic in Chicago, IL, December, 2015 (only two Middle School Jazz Bands in the world were selected to perform – Glades Middle School and one other group from Texas.)

The Glades Middle School Concert Jazz Band competed in the High School Division for Festival Disney. They earned the Best in Class Award, Superior Rating, and the first place Golden Mickey Award. The Band also received the highest rating of all High School Jazz Bands at Festival Disney, March 2016.

One student from the Glades Middle School Concert Jazz Band made the 2016 Florida Music Educators All State Jazz Band; two students made the 2017 Florida Music Educators All-State Jazz Band; the Concert Jazz Band received Straight Superior ratings under the direction of Mr. Rivero from the Florida Bandmasters Association Jazz Music Performance Assessments for eight consecutive years; and it has recorded five CDs professionally in a studio under Mr. Rivero's guidance. } Revised
